Holymoorside and Walton Parish Council has submitted a Neighbourhood Plan proposal under the Town and Country Planning Neighbourhood Planning (General) Regulations 2012 (reg. 15).

The Plan sets out a vision for the Parish and establishes the type of development needed to help sustain the community. If made, it will become part of the development plan for land use and development proposals within the Parish until 2033.

The Plan proposal has been submitted with a selection of documents and is supported by evidence used in the preparation of the Plan. These are available via the above web sites, and a selection at the above locations.

Following the consultation period the Plan will be examined by an independent Examiner, who will report to the District Council, following which they will decide what action to take and whether to go forward to 'make' the Neighbourhood Plan part of the development plan for the District. You may include in your comments a request to be notified of our decision on this plan.
